



## CHC50121 Diploma of Early Childhood Education and Care

### ABOUT THIS COURSE

This qualification reflects the role of educators in early childhood education and care who work in regulated children's education and care services in Australia.

Educators at this level are responsible for designing and implementing curriculum that meets the requirements of an approved learning framework and for maintaining compliance in other areas of service operations.

They use specialised knowledge and analyse and apply theoretical concepts to diverse work situations. They may have responsibility for supervision of volunteers or other educators. Early childhood educators work in long day care centres, family day care, pre-schools or kindergartens.

### ENTRY REQUIREMENTS

Entry to this qualification is open to individuals who hold:

- CHC30121 Certificate III in Early Childhood Education and Care; or
- CHC30113 Certificate III in Early Childhood Education and Care.

A pre-enrolment process to establish suitability to undertake the course and to determine support requirements will be conducted and will include a Language, Literacy, Numeracy and Digital skills (LLND) assessment.

### COURSE FEES

Course Fee **includes \$400 non-refundable enrolment fee**

Recognition of Prior Learning (RPL)

Course fees include all learning and assessment material (excluding textbook/s), and a certification upon successful completion. Students are responsible for the purchase of textbook/s relevant to this qualification.

Assessments vary with each unit, including questioning, project work, observations or supervisor reports. Students will be provided with a Training Plan and Assessment Guide.

## WORK PLACEMENT REQUIREMENTS

All students must be willing to participate in mandatory work placement of a minimum of 280 hours. This will require a working with children clearance.

## RECOGNITION OF PRIOR LEARNING (RPL) & CREDIT TRANSFERS

Students can apply for Credit Transfers and Recognition of Prior Learning during pre-enrolment or after enrolment. Students must complete an RPL Self-Assessment before applying, followed by an interview with an assessor, whereafter final assessments will be made based on evidence provided.
